GIANCARLO LAURINI ELECTED PRESIDENT OF NOTARIES

Rome, 7 June 2010 – **Giancarlo Laurini** has been elected President of the National Council of Notaries for the three-year period 2010-2013. He will be assisted as Vice President by Paolo Setti, notary of Milan. Donatella Quartuccio, notary of Pescara, will be the Secretary of the Council.

The officers of the body representing Italian notaries were elected today during a meeting to inaugurate the National Council of Notaries which was elected last February.

Laurini has been a notary in the District of Naples since 1970 and already served as President of the National Council of Notaries from 1992 to 1998. In 1995, he was head of CNUE, the Council of Notaries of the European Union, and from 2005 until 2007 of the International Union of Latin Notaries, of which he remains Honorary President. As a Deputy in the Parliament of the 15th Legislature (2006-2008), he was a member of the House Justice Commission.

He has been Professor of Commercial Law in the Faculty of Economics at the Università Federico II in Naples and is the Editor of the "Notariato" magazine. From 1995 until 2000, furthermore, he was President of the Consultative Body for the Professions as a member of CNEL and Vice President of CUP, the Unified Committee of the Professions.
